**General** – Last day to file is **October 27<sup>th</sup>, 2020**. Successful primary candidates need to file their received contributions

**Financial Statement of Contributions & Expenditures Amendments Report**

**Primary** – Last day to file is **August 28<sup>th</sup>, 2020**. File this document even if you have not received any money / contributions / expenditures.

**General** - Last day to file is **November 13<sup>th</sup>, 2020**. Successful primary candidates need to file their received contributions and expenditures.

**REMEMBER**

- ✓ Check with your City or town officials before placing signs in municipal right-of-ways as it may not be allowed.
- ✓ Be aware of electioneering restrictions and remember that the Courthouse is an absentee polling site. No campaign signage, brochures, bumper stickers, t-shirts or petitions are allowed within 100 yards of a polling place (W. S. § 22-26-113).
